



MIDDLE GEORGIA STATE UNIVERSITY AND THE TECHNICAL COLLEGE SYSTEM OF GEORGIA COURSE ARTICULATION AGREEMENT

Middle Georgia State University ("MGA") and the Technical College System of Georgia ("TCSG") agree as follows:

- 1. Purpose: This agreement assists and promotes the transferability of selected courses from the Technical College System of Georgia institution graduates with an AAS Computer Information Systems degree or certificate to the Bachelor of Science degree in Information Technology major at Middle Georgia State University.
- 2. Term and Termination: This agreement will be in effect November 1, 2021. Either party may elect to terminate this agreement by sending a written statement to the other party with at least one full semester prior notice of the termination.
- 3. MGA and TCSG institutions will agree to a specific list of courses in programs that will transfer from TCSG institutions to MGA. This agreement assures the acceptance by MGA of the TCSG courses as listed in Appendix A.
- 4. The joint program will be open to Technical College System of Georgia institution graduates with an AAS Computer Information Systems degree or certificate and only for candidates entering the online or face-to-face Bachelor of Science degree in Information Technology major at Middle Georgia State University.
- 5. Middle Georgia State University will accept the Computer Information Systems (CIST) courses listed in Appendix A from Technical College System of Georgia institutions as equivalent to Area F courses in the Bachelor of Science degree in Information Technology.
- 6. All CIST courses transferred to Area F will be taught by qualified faculty as determined by SACS-COC Comprehensive Standard 6.2a Faculty Competence. When determining acceptable qualifications primary consideration is given to highest degree earned in the discipline. Consideration is also given to the individual's competence, effectiveness, and capacity, including as appropriate, undergraduate and graduate degrees, related work experiences in the field, professional licensure and certifications ,honors and awards, continuous documented excellence in teaching, or other demonstrated competencies and achievements that contribute to effective teaching and student learning outcomes.
- 7. Each party agrees to inform the other regarding curriculum changes that may impact the terms of this agreement.





- 8. Each party agrees to notify the other of any adverse changes to its accreditation or state licensure status.
- 9. No modifications of the terms and conditions of this agreement will be binding upon either party except by a writing executed by both parties.

By signing this course articulation agreement, both parties agree to the terms outlined above.
