The following will occur during your advising appointment:

- Review of eligibility for acceptance (Ms. Miller)
- Applicants must have graduated from a regionally accredited and CoARC accredited Respiratory Therapy Program
- Applicants must meet the minimum GPA requirement
- Applicants must be an RRT which is verified through the NBRC (National Board for Respiratory Care) website
 - Review of transcripts with advisement toward any additional core needed (applicants may be accepted and begin RT coursework prior to core completion). (Ms. Carr or Ms. Miller)
 - Review of any needed petitions for coursework acceptance. (Ms. Carr or Ms. Miller)
 - If the applicant is accepted, the following will also be completed): (Ms. Miller)
 - Completion of Change of Major form)
 - o Registration for initial courses (or instructions for student to complete)-
 - Removal of advising hold)

The student is responsible for reviewing the current catalog toward degree requirements, assuring all needed petitions for coursework are completed and reviewing MyDegree each semester to assure all is in order and progressing.
