This is the 2nd year of assessment for the BA in Contemporary Musicianship. The first freshman class was enrolled in AY 2019. The majority of students enrolled in the assessment point courses began in the AA in Music degree and changed their major to the BA in Contemporary Musicianship when it became available. There is little historic data to assess. For AY20, an Student Learning Initiative will be implemented for SLO #4, assessed in Spring Semester, in MUSC 3322. The SLI relates to a reorganization of the course syllabus and calendar. Course pacing will be revised to accommodate cross-era listening activities. Additionally, study material for the listening portion of the final exam will be posted in D2L for review.

Open Box for Assessment Comments

Former AA in Music students auditioned for the BA in Contemporary Musician at various times during this inaugural year, AY19. The change of major forms were then prepared and sent to the Registrar's Office for processing. The migration of students from the AA to the BA program was ongoing and sporadic. The student enrollment numbers provided for in this report are reliable estimates.
