The Core Curriculum is being revised at the System level, and the outcomes in this report are subject to change. Additionally, with academic restructuring at Middle Georgia State University, not all courses are currently housed in the relatively new School of Arts and Letters. Core Courses are now with four separate Schools. Changes in the core curriculum are anticipated, and the MGA General Education Council will play a role.</p> |
